## **ORDER**

Before the Court are two motions for litigation expenses — plaintiff Gilbert P. Hyatt's motion for attorneys' fees under 28 U.S.C. § 2412(b) (ECF No. 262)<sup>1</sup> and defendant Patent and Trademark Office's<sup>2</sup> (PTO) motion for expenses under 35 U.S.C. § 145 (ECF No. 261) — as well as Mr. Hyatt's motions to de-designate certain evidence as protected under a protective order (ECF Nos. 207 and 240).

Upon consideration of the motion for attorneys' fees and briefing thereon, the motion is **GRANTED** in part and it is hereby **ORDERED** that Mr. Hyatt is entitled to an award of \$10,459.85 in attorneys' fees. It is further **ORDERED** that the PTO shall pay that sum to Mr. Hyatt within sixty days. With respect to all other fees sought, the motion is **DENIED**.

Upon consideration of the motion for expenses and briefing thereon, the motion is **GRANTED** in part and it is hereby **ORDERED** that the PTO is entitled to an award of \$60,797.44

in expenses. It is further **ORDERED** that the Mr. Hyatt shall pay that sum to the PTO within sixty

days. With respect to all other reimbursements sought, the motion is **DENIED**.

Upon consideration of the motions to de-designate certain evidence and briefing thereon, the motion is **GRANTED** in part and it is hereby **ORDERED** that the PTO has improperly designated the following documents as protected: PTX-615, PTX-272, PTX-115, PTX-119, PTX-124, PTX-141, PTX-133, and PTX-140. It is further **ORDERED** that the PTO shall re-produced these documents to Mr. Hyatt without any protected designation. With respect to all other relief
