The Court further **ORDERS** SSN to submit, by **May 27, 2014**, a five page brief specifically addressing the exhibits that have been objected to, and their relevance in view of the corroboration requirement. EON is **ORDERED** to submit a five page response by **May 29, 2014**.

The Court provides the following allocations of time for trial:

- Voir Dire: 30 minutes for EON and 30 minutes for SSN;
- Opening: 30 minutes for EON and 30 minutes for SSN;
- Direct and Cross Examination: 11 hours for EON and 11 hours for SSN; and
- Closing: 30 minutes for EON and 30 minutes for SSN.

With respect to the Joint Jury Questionnaire (Doc. No. 571), SSN and EON are **ORDERED** to provide 25 copies of a revised jury questionnaire omitting questions 19, 20, 21, and 23 to the Jury Administrator by **11:00 am on May 30, 2014**.

Additionally, SSN and EON are to email, as Microsoft Word documents, an updated joint proposed final jury charge and competing proposed verdict forms to Chambers Law Clerk Mr. Samples by **May 28, 2014**.

With respect to Jury Notebooks, EON and SSN are **ORDERED** to provide to Chambers, by **May 28, 2014**, eight identical Juror Notebooks containing the Court's Claim Constructions, a copy of each Patent-in-Suit, and if agreed by the parties a glossary of terms. The Court will provide the Jurors with note paper, a copy of the model patent addressed in the Federal Judicial Center video "An Introduction to the Patent System," as well as witness question forms.

Finally, the parties are encouraged to prepare agreed witness identification sheets to be passed out to each juror as each witness testifies, including nothing more than the witness's

name, title, photograph, and a generic single sentence description of the testimony provided by the witness.
