PROPOSED ORDER OF FINAL JUDGMENT


In accordance with the Court's prior orders in this case, the Court hereby orders as follows:

1. This is a patent infringement action brought by United Access Technologies, LLC ("UAT") against CenturyTel Broadband Services, LLC and Qwest Corporation (collectively, "CenturyLink") for infringement of U.S. Patent Nos. 5,844,596, 6,243,446, and 6,542,585.
2. This Court entered an order on December 20, 2013 (D.I. 81) granting CenturyLink's Motion for Judgment on the Pleadings.
3. Therefore, in accordance with the Court's order, the Court enters judgment FOR CenturyLink and AGAINST UAT on UAT's Counts I, II, and III, which assert infringement of U.S. Patents Nos. 5,844,596, 6,243,446, and 6,542,585.
4. All other defenses and counterclaims asserted by CenturyLink and not addressed by the Court's order are dismissed without prejudice as moot.
5. CenturyLink intends to seek its costs, pursuant to the procedures outlined by the Court's local rules.

6. This judgment is a final, appealable judgment for all purposes.

7. The CLERK IS HEREBY INSTRUCTED to enter final judgment as set forth above.
