PROPOSED ORDER OF FINAL JUDGMENT

It is hereby ORDERED AND ADJUDGED that, consistent with this Court's March 28, 2014 Order and Memorandum Opinion (D.I. 760; D.I. 761) granting the request of Plaintiff, The Dow Chemical Company for supplemental damages but denying its requests for a finding of willful infringement and enhanced damages, FINAL JUDGMENT is hereby entered in favor of Plaintiff and against Defendants Nova Chemicals Corporation, and Nova Chemicals Inc. Plaintiff is awarded supplemental damages in the amount of \$27,676,974. Additionally, Plaintiff is awarded prejudgment interest in the amount of \$2,773,922 through April 4, 2014, plus an additional \$2,711 per day from April 5, 2014 through the date of this ORDER.

THEREFORE, Plaintiff shall recover from the Defendants the sum of Thirty Million Four Hundred Fifty Thousand Eight Hundred and Ninety-Six Dollars (\$30,450,896) up through and including April 4, 2014, plus additional prejudgment interest as provided by this ORDER, postjudgment interest as provided by law and its costs of action.


