


establishing misappropriation of Trade Secrets 14, 18, 22, and 30,¹ and (2) the Plaintiff presented evidence conclusively establishing that Trade Secrets 8, 9, 15, 17, 23, 29, and 31 are, in fact, trade secrets and they were misappropriated by the Defendants. The court, having reviewed the evidence presented to the jury, is not inclined to disturb the findings of the jury. In light of the jury's verdict, the court finds that the Plaintiff's motion should be denied.

Based on the foregoing, it is hereby **ORDERED** that "Plaintiff Raytheon Company's Renewed Motion for Judgment as a Matter of Law, or in the Alternative, Motion for New Trial" (docket entry #826) is **DENIED**.

IT IS SO ORDERED.
