**JUDGMENT**

17 On August 24, 2016, Plaintiff Natural Alternatives International, Inc. filed the  
18 present action. (Doc. No. 1.) On March 20, 2017, Plaintiff filed a first amended complaint,  
19 the operative complaint, against Defendants Creative Compounds, LLC, Core Supplement  
20 Technologies, Inc., Honey Badger, LLC, and Myopharma, Inc., alleging claims for patent  
21 infringement and trademark infringement. (Doc. No. 48.) In the FAC, Plaintiff alleged a  
22 single claim for patent infringement against Defendant Creative Compounds, LLC. (Id. ¶¶  
23 127-31.)


24 On September 5, 2017, the Court granted Defendant Creative Compounds, LLC's  
25 Rule 12(c) motion for judgment on the pleadings, held that the patents-in-suit are all invalid  
26 under 35 U.S.C. § 101, and dismissed Plaintiff's claims for patent infringement with  
27 prejudice. (Doc. No. 89.) On October 20, 2017, the Court dismissed Defendant Honey

1 Badger, LLC with prejudice pursuant to the parties' joint motion to dismiss. (Doc. No.  
2 94.) On November 6, 2017, the Court dismissed Defendant Myopharma, Inc. with  
3 prejudice pursuant to the parties' joint motion to dismiss. (Doc. No. 96.) On November  
4 20, 2017, the Court dismissed Defendant Creative Compounds, LLC's counterclaims  
5 without prejudice as moot in light of the Court's September 5, 2017 order pursuant to the  
6 parties' joint motion to dismiss. (Doc. No. 98.) On November 27, 2017, the Court  
7 dismissed Defendant Core Supplement Technologies, Inc. with prejudice pursuant to the  
8 parties' joint motion to dismiss. (Doc. No. 100.)

9 In sum, all of the claims against all of the parties in this action have been resolved.  
10 Accordingly, the Court enters judgment in favor of Defendant Creative Compounds, LLC  
11 and against Plaintiff Natural Alternatives International, Inc. The Clerk is directed to close  
12 the case.
