AARON S. LUKAS, ESQ.
PRO HAC VICE**

This matter coming before the Court on the application of Defendant Sandoz Inc. ("Sandoz"), pursuant to Local Civil Rule 101.1(c), for an Order admitting counsel *pro hac vice*, Sandoz seeks the admission *pro hac vice* of Aaron S. Lukas, Esq. and the Court having received the certifications submitted in support of the application; and there being no opposition to this application; and for good cause shown,

IT IS on this 3rd day of October, 2011;

ORDERED that Aaron S. Lukas, Esq. member of the Bar of the District of Columbia and United States Patent and Trademark Office, be permitted to appear and participate *pro hac vice* in the above-captioned matters pursuant to L.Civ.R. 101(c), provided however, that all pleadings, briefs and other papers filed with this Court shall be signed by a duly admitted attorney and a member in good standing of the Bar of the State of New Jersey and this Court, and who shall be responsible for said papers, for the conduct of the cause and who shall be present before the Court during all phases of this proceeding, unless expressly excused by the Court, as well as be held responsible for the conduct of the attorney admitted *pro hac vice* pursuant to this Order; and it is further

ORDERED that Aaron S. Lukas, Esq. shall immediately notify the Court of any matter affecting her standing at the bar of any other court; and it is further

ORDERED that no adjournments of any motions, hearings, trial or any other proceeding shall be made for the absence of Aaron S. Lukas, Esq.; and it is further

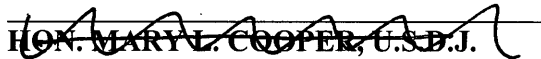
ORDERED that Aaron S. Lukas, Esq. shall not be designated as sole trial counsel in this action; and it is further

ORDERED that Aaron S. Lukas, Esq. shall send a copy of this Order granting her *pro hac vice* admission along with the annual fee to the New Jersey Lawyers' Fund for Client Protection in accordance with New Jersey Court Rule 1:28-2, an annual fee to the Oversight Committee to be used for attorney discipline and fee arbitration pursuant to New Jersey Court Rule 1:20-1(b), the fee of \$150.00 to the Clerk of the United States District Court, District of New Jersey pursuant to Local Rule 101.1(c)(3), and an annual assessment for the administration of the Lawyers' Assistance Program pursuant to New Jersey Court Rule 1:28B-1(e) within ten (10) days from the date of entry of this Order; and it is further

ORDERED that Aaron S. Lukas, Esq. shall be bound by the Rules of the United States District Court for the District of New Jersey, including, but not limited to, the provisions of L.Civ.R. 103.1, Judicial Ethics and Professional Responsibility, and L.Civ.R. 104.1, Discipline of Attorneys; and it is further

ORDERED that Aaron S. Lukas, Esq. shall be deemed to have agreed to take no fee in any tort case in excess of the New Jersey Court Contingency Fee Rule, Rule 1:21-7, as amended and to otherwise abide by the Rules of Court, including all disciplinary rules; and it is further

ORDERED that Aaron S. Lukas, Esq. shall consent to the appointment of the Clerk of the Supreme Court of New Jersey as agent upon whom service of process may be made for all actions against him or his firm that may arise out of his participation in this matter.
