#### PLAINTIFFS' AMENDED NOTICE OF APPEAL, USCA FEDERAL CIRCUIT CASE NO. 2017-2636

NOTICE IS HEREBY GIVEN that Salix Pharmaceuticals, Inc. and Dr. Falk Pharma GmbH (collectively, "Salix"), plaintiffs in the above-referenced case, hereby appeal to the United States Court of Appeals for the Federal Circuit from the district court's entry of final judgment under Fed. R. Civ. P. 54(b) of non-infringement of claim 1 of United States Patent No. 8,865,688 ("the '688 patent") (ECF No. 269), entered in this action on November 29, 2017, and all findings, rulings, determinations, conclusions, orders, opinions, proceedings, and decisions leading thereto, underlying, or incorporated therein, including the Findings of Fact and Conclusions of Law Granting Judgment in Favor of the Defendants (ECF No. 255). A copy of the Order Granting Unopposed Motion for Entry of Final Judgment (ECF No. 268) and Judgment in a Civil Action (ECF No. 269) are attached as Exhibits A and B, respectively.

On September 12, 2017, the district court issued Findings of Facts and Conclusions of Law granting judgment of non-infringement in favor of Mylan Pharmaceuticals Inc. and Mylan

Inc. (collectively, "Mylan"), and entered a Judgment in a Civil Action ("Non-infringement Judgment"). ECF Nos. 255, 256. On September 27, 2017, Salix appealed the Non-infringement Judgment to the Federal Circuit, docketed as Appeal No. 2017-2636. ECF No. 258. On November 7, 2017, the Federal Circuit subsequently ordered that Appeal No. 2017-2636 and Appeal No. 2017-2312 (which is an appeal by Dr. Falk Pharma GmbH from the Patent Trial and Appeal Board's final written decision that claims 1 and 16 of the '688 patent are unpatentable) shall be considered companion cases and assigned to the same merits panel.

On November 29, 2017, Mylan filed an unopposed motion requesting the district court to direct entry of final judgment under Fed. R. Civ. P. 54(b) of its September 17, 2017 judgment of non-infringement of claim 1 of the '688 patent. ECF No. 267. On November 29, 2017, the district court granted Mylan's unopposed motion (Ex. A) and entered final judgment under Fed. R. Civ. P. 54(b) of non-infringement of claim 1 of the '688 patent (Ex. B).

In conjunction with the filing of this Amended Notice of Appeal, Salix and Mylan are filing a joint motion in Appeal No. 2017-2636, requesting that the Federal Circuit accept this Amended Notice of Appeal without issuing a new appeal number, maintain the current briefing schedule, and continue to consider Appeal Nos. 2017-2636 and 2017-2312 as companion cases assigned to the same merits panel.
